### [Irish Sea Marine Conservation Zones Final Report Published](#)

After two years of intense work, the Irish Sea Conservation Project is at an end. The project, which aimed to recommend areas for marine conservation in the Irish Sea has involved over 50 individuals, representing all coastal stakeholders in the North West. The final recommendations report has been delivered to the Government, along with the final reports from the 3 other three regional projects, Net Gain, Balanced Seas and Finding Sanctuary.

DONG Energy is seeking community views on all aspects of their initial wind energy proposals to help inform the development of a planning application for an extension to the already consented Walney Offshore Wind Farm. Five public meetings are being held to discuss the proposals:

**Isle of Man:** Thursday 15th Sept – 1pm-7pm – Villa Marina, Harris Promenade, Douglas, Isle of Man, IM1 2HJ

## [Blackpool and Fylde Coast Protection Strategy Consultation](#)

Consultation is underway on a draft Coast Protection Strategy for Blackpool and the Fylde, together with the associated Strategic Environmental Report and other supporting documents. The draft Strategy has been produced by Blackpool Borough Council in partnership with Fylde Borough Council to manage current and future risks along the Fylde coast, where it is predicted that as sea levels rise over the next 100 years more than 23,000 homes will be at risk of coastal flooding and erosion between Kingsway, Blackpool, and Naze Point, Lytham. The draft Strategy builds on policies in the North West England and North Wales Shoreline Management Plan.

## [Partnership Working in Support of Marine Spatial Planning in the Irish Sea](#)

Over the course of spring 2011, the University of Liverpool, in collaboration with the North West Coastal Forum and the United Kingdom's National Oceanography Centre, organised two events aimed at exploring stakeholder views on the future development of transnational partnership working to support co-ordinated marine spatial planning in the Irish Sea region. The work was funded by the United Kingdom's Economic and Social Research Council and was guided by a Steering Group which included representatives of marine planning agencies from the six jurisdictions that border the Irish Sea.

A website has now been created for the project and a report summarising the outputs of the two events has been produced by Liverpool University. It provides an overview of:

- the background to the initiative
- the aims and content of the two events which were held in Liverpool and Dublin (including the presentations)
- the outputs to emerge from stakeholder discussions
- a proposed plan of action to foster improved transnational partnership working in the Irish Sea.

### [The Heritage Value of Modern Shipwrecks](#)

English Heritage, with funding from [MEDIN](#), has completed a project to expand its database of historic wrecks to include postwar losses. ## [Defra Launch Grant Scheme for Nature Improvement Areas](#)

Defra has launched a new grant scheme to establish Nature Improvement Areas (NIAs). NIAs are large, discrete areas that will deliver a step change in nature conservation, where a local partnership has a shared vision for their natural environment. The partnership will plan and deliver significant improvements for wildlife and people through the sustainable use of natural resources, restoring and creating wildlife habitats, connecting local sites and joining up local action.

Twelve NIAs will be established, using a £7.5m fund.

## [Biodiversity News and Consultation on Indicators](#)

Defra has recently published *Biodiversity 2020 – a new strategy paper for England's wildlife and ecosystem services*. The document sets out the Government's approach to halting the decline in biodiversity over the next decade on land (including freshwater systems) and sea, building on the Natural Environment White Paper and taking into account our international biodiversity commitments.

In addition a consultation is taking place on a new set of indicators to measure progress on Biodiversity 2020. The consultation is in the form of a technical discussion paper and invites comments on the scope and detail of the indicators. The consultation close date is **11th November 2011**.

## [National Flood and Coastal Erosion Risk Management Strategy](#)

The Environment Agency has now published the National FCERM Strategy as required under the Flood and Water Management Act 2010. This strategy sets out a statutory framework which will help all those involved in flood and coastal erosion risk management and local communities to work together to manage flood and coastal erosion risks. It will support local decision making and engagement and ensure that risks are managed in a co-ordinated way across catchments and along each stretch of coast. It includes the development of local flood risk management strategies. Organisations directly involved in FCERM include local authorities, internal drainage boards, water and sewerage companies and highways authorities, as well as the Environment Agency itself.
