SUSTAIN Project Update

November 9, 2011

SUSTAIN, an EU-funded Interreg project that Sefton Council and the North West Coastal Forum are a part of, continues a-pace. The Europe-wide project, which aims to develop a universal policy tool to measure coastal sustainability, is nearly two-thirds complete with a final launch conference due to be held in Southport in September 2012.

From a Forum perspective, the latest work has largely involved being part of a small working group tasked with refining a draft indicator set into a final, uniform set with clear language and descriptors before Christmas. This will then be ground-tested by all project partners in the first 3 months of 2012 with feedback to be given in March. The feedback will be incorporated in final revisions between March and September, when an Implementation Guide and a Guide to Improving Sustainability will be written.

Ribble & Dee Estuary Cockle Beds Closed Over Safety Concerns

November 16, 2011

All Cockle beds at the Ribble and Dee Estuaries were closed on 7 November over fears to fishermen's safety. The major cockle bed in the Ribble Estuary, on Foulnaze bank between Lytham and Southport, has been estimated to be worth £8million and has been attracting up to 300 cocklers a day.

The huge stock has led to cocklers arriving from all around the country, some of whom attempted to work illegally without the required NWIFCA permit. Access to the bed requires use of small boats many of which did not have safety equipment. Fishers with no experience of using small boats in the Ribble were going out in adverse weather at night resulting in more than 20 calls to the emergency services since the fishery opened on 1 September. A spot check showed 50 cocklers operating without permits and 15 boats deemed to be unsafe.

Amid fears of a serious tragedy, the North West Inshore Fisheries and Conservation Authority (NWIFCA) has passed an emergency by-law, which closed the Ribble bed from Monday 7 November, bringing forward the date from April. It is hoped that the fishery will be re-opened as soon as possible, when improved controls can be implemented.

To prevent relocation of cocklers and protect stocks, the Dee Estuary cockle bed on the Wirral has also been closed.

UNSECO inspectors to visit Liverpool World Heritage Site

UNESCO staff are visiting Liverpool this week (Monday Nov. 14) on a 3-day monitoring trip to assess the impact of a skyscraper regeneration scheme in the city's docklands. Planning documents for the Liverpool Waters redevelopment scheme have been submitted, and concerns have been raised that the status of the city's waterfront World Heritage Site would be in jeopardy should planning permission be granted.

Brunel's Last Launch

November 9, 2011

A Time Team Special aired on Thursday 10th November at 9 pm features some North West maritime archaeology. The programme focuses on the problematic launch of Brunel's innovative SS Great Eastern on the Thames but part of the programme investigates the site where SS Great Eastern was scrapped and broken up between 1889 and 1891 – the mud flats at Rock Ferry on the Wirral. A familiar face will feature – Mike Stammers, maritime archaeologist and former director of the Merseyside Maritime Museum. National News

Localism Bill Enacted

November 16, 2011

The Localism Bill received Royal Assent on 15th November. It introduces far-reaching changes to the planning system including abolition of regional strategies and the Infrastructure Planning Commission and the introduction of neighbourhood plans with wide community involvement. Many of the measures introduced are expected to be in place by April 2012.

Ministerial Statement on Marine Conservation Zones

November 16, 2011

Environment Minister Richard Benyon has made a Written Ministerial Statement (on Nov 15) on marine conservation zones. The statement confirms a delay to the original timetable, with Natural England and

the Joint Nature Conservancy Council (JNCC) providing their advice to Government in July 2012, six months later than planned.

A set of new guidelines for tackling oil or chemical spills at sea has been published. The guidelines provide the principles upon which effective post-spill monitoring and impact assessment in UK waters will be based on and are supported by the 19 UK government partners involved in post-spill issues.

Bathing water results for 2011

November 8, 2011

Defra have published details of the 2011 bathing water results – a mixed picture for the North West with 24 beaches meeting the mandatory bathing water requirements compared to 27 in 2010, however 9 of these achieved the exacting requirements of the revised Bathing Water Directive standards (current 'guideline' status) compared to only 6 last year. However several key beaches in Lancashire failed (6 failures compared to only 3 in 2010). Marine Nature Reserve Designated in Isle of Man

October 24, 2011

Ramsey Bay has been designated as the Isle of Man's first Marine Nature Reserve (MNR). The MNR will protect marine life, safeguard local fisheries and provide opportunities for Ramsey to develop as a centre for marine tourism, research and education.

After 3 years of community consultation, the by-laws to protect the MNR came into effect on October 1st. The by-laws protect the entire bay from aggregate dredging and the dumping of dredged material, and a zonation system offers different levels of protection for different areas of the bay.
