## INTRODUCTION

Following two stakeholder workshops that were held in Liverpool and Dublin in 2011, an initial Steering Group was set up including representatives from marine planning teams across the Irish Sea to establish a new Irish Sea Maritime Forum. The initiative has received pump priming financial support from the Department of Environment in Northern Ireland, The Isle of Man Government and the Marine Management Organisation and the Irish Planning Institute and secretarial support from the North West Coastal Forum and the University of Liverpool. Drawing on the outputs from the 2011 events a draft vision and objectives for the forum have been set out.

### **Draft Vision for Irish Sea**

**An Irish Sea which has a healthy marine environment, coherent energy policy, safe clean and efficient transport and sustainable fisheries and is managed to deliver sustainable development for the benefit of all.**

### **Objectives of the Forum**

- To provide a broad based forum for all Irish Sea users and provide an opportunity for voices to be heard
- To facilitate knowledge exchange and capacity building across all administrative areas and sectors about marine planning
- To facilitate sharing of data and information
- To encourage and maintain political support for transnational partnership working in support of marine planning, with the aim of promoting sustainable development in the Irish Sea region.
- To facilitate a more coordinated, efficient planning process for transnational issues/projects and good working relationships among Irish Sea partners

The conference held in the new Titanic signature building in Belfast on 28 June 2012 marked the formal inauguration of the Forum and was open to all with an interest in the Irish Sea. The morning session provided stakeholders with an opportunity to hear the latest news on marine planning across the Irish Sea. The afternoon session focused on important areas for the Forum's future activities including the emerging European Union Atlantic Strategy. A key component of the afternoon was a workshop where stakeholder views on the focus of future activities and events, website development and financing were discussed. This note provides a summary of the proceedings and outputs for the day and the programme of activities for 2012/13 that has been developed taking account of stakeholder inputs.

## SUMMARY OF STAKEHOLDER DISCUSSIONS

### What should be the focus of future ISMF actions and events?

Appendix 1 draws together the outputs of stakeholder discussions related to future ISMF actions and events. Key points to emerge include:

1. There is broad support for the objectives of the Forum which were drawn from the 2011 stakeholder events, although there is possibly a need for refinement and formal agreement of these over the course of the next year. However, there is also a sense of stakeholders being keen to move on and for effort to focus on outputs in order to build trust and support.
2. In terms of actions it is clear that the information exchange / networking role of the Forum is welcomed and that a focus on website development and formalisation of stakeholder links to the Forum perhaps through membership registration and a stakeholder mapping exercise would be useful next steps.
3. There is also much interest in drawing together data related to the Irish Sea and encouraging data coordination and identification of data gaps. Some early work, perhaps through initial scoping work in selected thematic areas and linked to website development would be useful..
4. Stakeholders recognise the potential role that the Forum could play in acting as a sounding board in future policy/ plan development. Although MSP is at an early point in the region some activity to establish a relationship with key agencies would be of interest.
5. With this in mind, and a point of debate in the discussions, was the extent to which the Forum should develop a lobbying role. Possible conflicts with its information exchange, networking functions were raised. One possible way forward suggested by one group is an audit of stakeholder concerns/issues. This might link to the suggested stakeholder mapping exercise and to proposals for thematic leads/sub groups discussed below.
6. Regular events targeted at particular audiences and emphasising stakeholder discussions with clear outputs were called for, with such workshops perhaps complementing a larger scale annual event. An early decision on the pattern of events for 2012/2013 and other activities would be useful to build confidence, create certainty and manage expectations.
7. The agenda above has significant financial and staffing implications which go beyond the limited resources currently available. However these may be partially addressed by the proposed development of the Steering Group to include thematic leads and development of a working group/advisory group structure as well as the financing suggestions discussed further below. Again these are important areas for decision at this point in time.



## **What should the Forum's website cover?**

Appendix 2 draws together the outputs from the discussion groups related to the development of a Forum website. As can be seen from the above this is identified as an important early action point although one which will need to develop in sophistication over time subject to the availability of resources. Key points that can be distilled from the discussions for early consideration include:

1. The need to be clear about the audience for the website and perhaps aim in the initial instance particularly at potential stakeholder members and develop the website in a way that encourages their engagement with the Forum and facilitates networking between them.
2. The website should give a clear description of the role, objectives and structure of the Forum including Steering Group membership and contacts.
3. The website should act as an information portal for the Irish Sea drawing together relevant sources. There was however some discussion about the value of simply listing existing resources and it was suggested that the site should try to add value in some way. Linked to this should be consideration of the extent to which the website should be reactive or proactive in its style.
4. Protocols for web content, maintenance and updating need to be developed.
5. The development of a newsletter function of the website and associated email updates to stakeholders should be considered in the longer term.
6. Hosting of the website was raised, with one discussion group favouring hosting by a non-governmental organisation.
7. Full development of the website as an Irish Sea data portal would require specialist technical input possibly guided by a specialist working groups and could be the focus of a separate funding bid.

## **How can the Forum's activities be financed?**

Appendix 3 draws together the output of stakeholder discussions related to the key issue of future funding for the Forum. Here all groups emphasised the need for a clear link between the Forums' objectives, activities and outputs to draw down resources. There was also recognition during the day of the need to tailor the Forum's activities around topical issues and funding opportunities and for it to act as a conduit for stakeholders to come together to make their own funding bids. The following were identified as key potential funding possibilities.

1. Sponsorship from private and public sector stakeholders perhaps linked to particular deliverables/events.
2. Membership contributions at a relatively low level might form a useful background level of financing.
3. EU sources particularly with the development of the Atlantic Strategy were seen to be the most promising form of funding for central secretarial and technical support, but also for other Forum related activities that would be of value for stakeholders.
4. Various sources of research money which increasingly promote research practice connections could be targeted alongside other sources such as the Big Lottery.
5. The potential for levies or 'planning gain' associated with development in the Irish Sea being linked to Forum activities is worth exploration.

## OTHER STAKEHOLDER INPUTS FROM THE DAY

### Comments on the Draft Vision

A few participants submitted comments on the draft vision for the Forum set out in the introduction to this report. One said it is fine as it stands, another felt more reference could be made to terms such as shared, coordinated and cooperation. Mention was also made about the use of the word 'healthy' in the vision and whether more tangible terms such as 'biodiverse' would be preferable. In relation to omissions, it was suggested that marine tourism should be added. A comment was also received about the Forum's objectives suggesting that some would benefit from adjustment to make them more task-driven. Based on the above some further refinement of the vision and objective should be considered.

This illustrates that the range of stakeholder groups who are interested in playing an active part in the Forum's activities includes those from the public, private and voluntary sectors involved in fishing, environment, tourism and recreation, and maritime data and research. Reference to the delegate list from this and the previous workshops held in Liverpool and Dublin suggest that in addition there is potential interest from those involved in marine energy development and ports and shipping/navigation. There is also evidence of interest from all parts of the Irish Sea region.

## **Comments from the Feedback Forms**

Based on the feedback forms it is evident that the inaugural conference of the Forum was very well received, with over 90% assessing the event as good or excellent. All the comments collected from the forms are set out in Appendix 4. These provide a useful indication of issues that need to be considered in planning future events and also in guiding the next steps for the Forum. A review of the comments suggests that key areas for consideration include:

1. Maintaining momentum and responding to stakeholder interest with a programme of activities with clear outcomes and outputs that demonstrate the value of the Forum. This should include topic focussed elements and further opportunities for networking and information exchange. Connection to planning and management activities at local, national and Irish Sea scales and to EU related developments should be encouraged.
2. Developing clarity in the remit, mode of operation and management structure of the Forum. This should include consideration of ways in which politicians and local communities can be connected to the Forum's activities.

## ISMF PROGRAMME 2012/13

Drawing upon the stakeholder workshop discussions and other stakeholder inputs received on the day, a programme of activities for the first year of the Forum has been developed. All delegates from the Liverpool, Dublin and Belfast events will be circulated with further details related to these activities and they become available and details will be posted on the ISMF website following its launch in October 2012.

#### Appendix 4: Comments received from the delegate's feedback forms

Excellent range of stakeholders, liaison/discussion with stakeholders (networking), updates on marine planning and Atlantic Strategy. Workshops starting to focus on tangible actions and outcomes. Excellent building/body of support for the forum.

Lack of definite vision of the central role of the forum. Disappointing information on details of spatial planning.

Very useful and informative

Good to rotate venue to all regions. Consider presentation from each sector and how they fit into the Irish Sea. Group needs to keep momentum with regular updates. A basic website is simple but does need effort – it should be the initial catalyst.

Overall interesting – it would be good to get a copy of all the presentations. Given the potential of the Forum I would be interested in having another more focussed meeting on a specific topic e.g. implementation of MSFD.

ISMF needs to deliver something by the way of an action that can show its value e.g. coordinating discussion on MCZs in different Irish Sea administrations or an analysis of social/economic value of fishing across the Irish Sea. Product or outputs will encourage buy-in.

Would benefit from all presentations being in the pack. Screen not big enough.

Some repetition between speakers. Ok for first ISMF meeting. Future ones need to be more focussed with specific outcomes, more time for networking, could have more stands

Attwood's presentation was an eye opener to parochial nature/approach/viewpoint to issues in NI. Don't for a minute think that his views are indicative of the wider thought processes as work at this side of IS but perhaps indicative of environment in which policy decisions may be made. Updates from IS administrations useful.

Extremely interesting and relevant conference. Well organised and efficiently chaired.

Very informative update following on from Liverpool and Dublin. Worthwhile and interesting discussions and workshops.

Unclear what the conference was aiming to achieve. The first part of the day was really useful but the afternoon a bit stale as I think that most participants were unclear as to what the ultimate role of the Forum is – perhaps that was the point of the day? Great that it ran to time!

Dont think we need a print out of all the powerpoint slides for each and every delegate, most will never be looked at again. Surely it is in the interests of resources and reducing waste it would be better to email them and give people the choice

I think the forum is in danger of having what Einstein said is a profusion of ? and a confusion of ends. I thought this forum would have as one of its primary aims of advocating on behalf of local coastal communities and in that respect it will be Political in nature. Unless local politicians can see its point, funding etc is either irrelevant or easy!

On occasion it was difficult to see what the speakers were presenting. Great networking opportunity.

In future, and acknowledging that this was the inaugural conference, it would be useful to have more time for discussions on focused topics which could feed into current government consultations/early engagement/marine planning etc.

Very useful but need clarification on outcomes of the Forum and key objectives in the longer term.

Some good speakers and some not so good. Didnt feel the workshop sessions were very useful. It was good to find out about the forum and some good ideas came out.

As a single event I felt that it was excellent. Both well organised and a great forum for the sharing of information about how each state is progressing MSP. However, on a broader note, it is concerning that the forum doesn't have a clear remit and the afternoon sessions showed that different attendees had different intentions/aspirations for the forum. Without a clear direction/remit the forum will struggle to continue despite the obvious good will in the room. This is needed ASAP.

Looking at the Irish Sea as one and not different bits

Really worthwhile day – might be good to include some current marine research project findings that are ongoing, e.g. PISCES – but excellent to see that there will be outputs and future meetings.

Pembrokeshire Coastal Forum have an excellent mapping tool that could be developed further for wider ISMF use.

Venue too hot. Option to choose a workshop to be in may have led to having more informed participants.

Very informative, but information was fractions of too many points.

Further opportunity for questions and discussions welcome. In relation to the last session would perhaps have been useful to focus on question A as B and C are very much dependent on that.
