# SUSTAIN: new indicator toolkit for coastal localities available now

#### Posted on December 18th, 2012

The final outputs from the SUSTAIN project – part-funded by the European Regional Development Fund through the INTERREG IVC programme – are now available together with the presentations and other information from our recent Delivering Sustainable Coasts conference from the SUSTAIN project page: http://www.nwcoastalforum.org.uk/projects/current-projects/sustain/. SUSTAIN – Assessing sustainability and strengthening operational policy – has been a 3-year project (2010-2012) It was a Regional Initiative addressing environment and risk prevention (Priority 2 of the programme) and the sub-theme water management. The project budget was €1.8m.The project partnership was made up of 12 partner organisations from across the EU. The lead partner for the project was the Coastal & Marine Union – EUCC (The Netherlands) and the project was taken forward in North West England by Sefton Council working with the North West Coastal Forum. Burbo Bank Extension offshore wind farm, DONG Energy Burbo Extension (UK) Ltd (Pre Application stage) Extension to Burbo Bank Offshore Wind Farm. The application is expected to be submitted March 2013. http://infrastructure.planningportal.gov.uk/projects/north-west/burbo-bank-extension-offshore-wind-farm/

#### Walney Extension Offshore Wind Farm, DONG WIND (UK) Ltd (Pre Application stage)

Construction of Wind farm Extension Located West & Northwest of the existing offshore wind farm with an estimated 572 to 768 MW of installed capacity provided by 109 to 209 wind turbines. The application is expected to be submitted in the first quarter of 2013.

Mersey Tidal Power, Peel Energy (Archived projects) Tidal power generation facility. This project has been withdrawn by the developer.

#### Preesall Saltfield Underground Gas Storage, Halite Energy Group Ltd (Decision stage) An

underground gas storage facility to store gas in, extract gas from and inject gas into, with a total storage capacity up to 900 million standard cubic metres and working capacity of up to 600 million cubic metres including: up to 19 operational caverns formed by solution mining of the Preesall halite deposit all to be constructed to any extent downwards below 220 metres below ground surface and to be confined in the Preesall halite deposit; 7 multiple wellhead compounds and a Gas Compressor Compound. The examination closed on 24 October. The findings and conclusions arising from the examination, together with the recommendation from the Planning Inspectorate, will be sent to the Secretary of State of the Department of Energy and Climate Change within three months i.e. by 24<sup>th</sup> January 2013.

Alexandra Dock Biomass Project, RES UK & Ireland (Pre-Application stage) A new Biomass energy project, output between 100 and 150MW, in the Port of Liverpool. The application is expected to be submitted in the second quarter of 2013.

**Heysham to M6 Link Road, Lancashire County Council (Decision stage)** A new dual carriageway approx. 4.8 kms long to the north of Lancaster linking Junction 34 of the M6 with the junction of the A683 and A589 by Lancaster and Morecambe College. The project includes remodelling Junction 34, a new bridge over the River Lune and a 600 space park and ride site. A recommendation has been issued to the Secretary of State by the Planning Inspectorate and the decision is expected by 19<sup>th</sup> March 2013. http://infrastructure.planningportal.gov.uk/projects/north-west/heysham-to-m6-link-road/

Roosecote (Barrow) Biomass Power Station, Centrica Energy (Archived Projects)

A power station generating up 80MW (net) of renewable electricity and related development including loading and handling facilities at Barrow Docks and a new transportation system (rail and/or conveyor) to move fuel from the docks to the power station site. Nugen's Moorside Project in West Cumbria, NuGeneration Limited "NuGen" (Pre Application stage) New Nuclear Power Generating Station (up to 3.6GW), with ancillary and other associated development. The application is expected in 2014. http://infrastructure.planningportal.gov.uk/projects/north-west/nugens-moorside-project-in-westcumbria/ North West Coast Connections Project (N Grid), National Grid (Pre Application stage) Proposed 400kV electricity transmission connections from NuGen's proposed new nuclear generating station to be known as Moorside (near Sellafield) in West Cumbria to the existing transmission system in Cumbria/Lancashire. ## Liverpool 2 given the go ahead

#### Posted on December 17th, 2012

The Marine Management Organisation has approved an application for consent from Mersey Docks and Harbour Company Ltd (part of Peel Ports Group) to carry out construction and dredging to create a new deep water terminal of 17 hectares in the outer Mersey Estuary at Seaforth Docks. This development will provide facilities for 2 post-Panamax container vessels to dock at the same time and will increase container capacity at the port to an estimated 1,500,000 teus. # MMO publishes first series of marine evidence and information reports

The Marine Management Organisation (MMO) has published a series of reports on activities in and around English seas. These are part of the MMO's work to identify and fill gaps in knowledge that marine planners, regulators and users currently face and they make recommendations on what information is needed to support MMO decisions, and how the evidence base could be developed in the future. The information from the reports will be used to shape marine plans, and to ensure all marine uses are fully taken account of as the MMO plans for the future of our seas.

The reports published recently are:

- Review of fisheries resource and activity in England
- Socio-economic data report and tools review
- Compilation of spatial data on marine recreational activities
- Seabed habitat mapping

The MMO will continue to publish data reports to build further on the marine evidence base.

## Isle of Man Marine Plan – Statement of Public Participation

The Manx Government's Department of Infrastructure has released a Statement of Public Participation to outline how and when interest groups and members of the public can have their say on formulation of the Isle of Man Marine Plan.

# **International News**

## **EU Fisheries Reform**

Posted on January 3rd, 2013

On 18 December 2012, the Fisheries Committee of the European Parliament voted to support the key elements of the Commission's proposal for a new Common Fisheries Policy.

Three proposals for new laws are still under negotiation: the new CFP, the European Maritime and Fisheries Fund (EMFF) and the Common Market Organization. Negotiations between the Parliament and the Council are aimed at reaching a compromise on the whole reform package as soon as possible in 2013. This would allow the package to enter into force by 2014 at the latest.

Ireland, which will hold the Presidency of the Council in the first half of 2013, has made the CFP reform the priority of their work in fisheries.

# **Open Consultations**

# Triennial Review of the Environment Agency and Natural England

#### Posted on December 17th, 2012

The start of the Triennial Review of the Environment Agency and Natural England was announced recently by Environment Secretary Owen Patterson. This review is part of a rolling programme of triennial reviews of public bodies to consider whether the functions carried out by the body are still required and whether the delivery model is right and offers value for money.

As part of the review workshops are being arranged. On the 16th January 2013 a workshop for marine industry and conservation organisations is planned. This will provide an opportunity to consider the triennial review of the Environment Agency and Natural England with regard to marine

issues and will look at the interfaces between Environment Agency, Natural England and other bodies with responsibilities related to the marine environment, including the Joint Nature Conservation Committee. JNCC is also expected to be the subject of a triennial review in 2013 and the workshop will provide an opportunity to feed in views as part of the preparation for the JNCC triennial review.

A discussion document has been produced looking at a range of options from some internal restructuring to merging the two bodies. ## **Cumbria Coastal Access Consultation**

#### Posted on December 17th, 2012

Natural England have published the final report for coastal access roll-out between Allonby and Whitehaven. This report sets out the proposals to the Secretary of State for improving access to this stretch of coast. It follows a public consultation on the draft proposals which ran in early summer 2012. A further 8-week period of consultation is now taking place and will close on **Monday 11th February 2013**. Following consideration of the proposals and any representations and objections the Secretary of State will then make a decision on the route.

# Irish Sea Marine Conservation Zones Consultation

#### Posted on December 17th, 2012

Defra has published the consultation documents for the first tranche of Marine Conservation Zones. The consultation runs until midnight on **31st March 2013**. This is the key opportunity for everyone with an interest in the marine and coastal environment to influence which MCZs are designated. Information gathered during this consultation may also be used to influence which sites are put forward in later tranches.

In judging which sites to include in this initial round of designations Defra has stated that its aim has been to find the right balance between the strength of the conservation advantages an MCZ offers relative to the socio-economic implications of its likely designation. Whether an MCZ, and all of its features, are suitable for designation in the 2013 tranche depends on the levels of confidence in the scientific evidence and the balance between the site's conservation advantages and the socio-economic costs.

Only 4 of the 15 MCZs (19 including the recommended reference areas) put forward by the Irish Sea Conservation Zones Regional Stakeholder Group have been included in this first tranche to be considered for designation. These are:

- Cumbria coast but only for Honeycomb Worm (*Sabellaria alveolata*) reefs just 1 of the 8 features identified as the other 7 require further data
- Fylde offshore for both features identified (subtidal sand and subtidal sands and gravel)
- Hilbre Island Group for both features identified (Blue mussel *Mytilus edulis* beds and Peat and clay exposures)
- North of Celtic Deep but only for subtidal coarse sediment and subtidal sands and gravels just 2 of the 4 features identified as the others require further data
